The equipment is a luminaire for portable or fixed installation with one LED light module supplied with electronic control gear. The light module and control gear are moulded within a dissipative polycarbonate tube with metallic end plates. There are two different drivers – one for 24-48 V version and one for 110 V and 230 V versions. The luminaire has a permanently connected supply cable.
